TERMS AND CONDITIONS OF ENTERING

Your photo on your TASMAP! (the 'Competition')

Land Tasmania

TASMAP is looking to update the covers of its National Park paper maps. We are looking for beautiful, inspiring photos which offer a new perspective on the Tasmanian landscape and focus the full emotional force of imagery.

We are asking keen photographers of all ages to submit their photos. The photos for each map cover will then go forward to a panel of judges who will select the winners. These will then appear on the applicable map cover. A prize (National Parks Map Set valued at \$76) will be awarded to each judged winner.

The rules of the Competition are set out below. Please read these carefully before entering your photos.

TERMS AND CONDITIONS

- 1. The Competition is open to all Australian residents.
- 2. The Competition is open to photographers of any age.
- 3. The Competition is open to amateur and professional photographers alike. However photos which have previously won a photographic competition and/or have been published professionally in any media will not be eligible.
- 4. Please be aware that the Competition is open to DPIPWE employees and their families. However whilst we will consider their photos for publication on our map covers, such persons will not be eligible to win prizes.
- 5. No purchase is necessary to take part in this Competition.
- 6. The Competition will close at midnight on the specified date for each map.
- 7. To enter your photo into the Competition, please submit via the allocated email address. We regret that we cannot accept entries by post.
- 8. As part of your entry you must:
 - a. Provide your name, contact phone number, email and postal address and brief description of your photo and where it was taken; b. Indicate that you (or the responsible parent/guardian) agree(s) to the Competition terms and conditions.
- 9. You must tell us the location from which your photo was taken or the location which is depicted in the photo (whichever is the more relevant to the view depicted in the photo).
- 10. Your image file must be a colour photo in excess of 95mm in height by 115mm in length, in a jpg or tiff format
- II. Your photo must be of the landscape or have the landscape as its background, showing real features. It must be taken in Tasmania and it should not be a fictitious, invented scene; have elements superimposed onto a scene, or be a mosaic of images.
- 12. Your photo may include people but they should not be identifiable. It may include animals, although photos which focus on your domestic pets are not eligible.
- 13. You must obtain the permission of any people featured in your photo or their parents/guardian if children under 16 are featured. You must obtain the permission of the owners of any private residential property featured in your photo. You must provide written evidence of such permission, if requested.
- 14. Photos should not contain any material or images that are obscene, indecent, offensive, defamatory, unlawful or would be detrimental to the reputation/goodwill of the Crown in right of Tasmania or any of its employees or agencies;
- 15. Your image may be cropped (although we reserve the right to choose the original size and composition) and it may be digitally enhanced to remove blemishes, brighten or alter the colour of the image or have other minor features changed. However, we reserve the right to exclude any images which we believe have been substantially enhanced so as to no longer be authentic.
- 16. You can submit as many photos, from/for as many locations as you like. There is no maximum limit to the number of photos you can enter. However, entries made on behalf of another person, or jointly with another person are not acceptable.

VOTING AND JUDGING PROCESS

- 17. After the closing date for each map series, the photos will go forward to the judging panel.
- 18. A panel of judges will pick the winning photos for each map. The winning photo will then feature on the next print run of that map sheet.
- 19. If no suitable entries are received for the area depicted in any particular map sheet, we reserve the right to use our own photo, or an independently sourced photo, for use on that map cover and no prize shall be awarded.
- 20. Winners will be notified via email within I month of the closing date for each map series.
- 21. All winning entries will be subject to a final check and any which are found to be in breach of the Competition terms and conditions will be disqualified and any prizes forfeited. The judging panel will then select a new winner from the remaining shortlisted photos for that particular map sheet.
- 22. We will publish all the winning photos on the TASMAP website. We will also publish a separate list of the winner's names on the TASMAP website.

WHAT THE JUDGES WILL BE LOOKING FOR

- 23. The judging panel will consider various criteria when choosing the winners for each map series, including the relevant style and focus of the map series; the subject matter, composition, quality and freshness. The winning photos should inspire the judges and/or make them wish they had visited, or could visit, the location. There will clearly be an element of subjectivity in this respect.
- 24. The judge's decisions will be final and no correspondence will be entered into.

PRIZES

- 25. The winning photos will be incorporated into the relevant map cover, along with the winning entrant's name on the back cover, when that map next goes to reprint. This means it will be displayed on thousands of maps, in thousands of retailers across Australia and potentially further afield.
- 26. The winning entrants will also receive:
 - a. Complimentary flat copy of the relevant map on which their photo features, once that particular map has gone to reprint. b. National Parks Map Set valued at \$76 from the TASMAP website.
- 27. Winners will be notified via email within 1 month of the closing date for each map. We will provide you with full instructions on how to claim your prize, which must be claimed within 12 months of the closing date.
- 28. In the event that the overall winner of the main Competition is under 18 years of age, the prizes referred to above will be supplied to their parent/guardian.
- 29. Prizes are non-transferrable and cannot be exchanged for cash. We do reserve the right to substitute.

YOUR OBLIGATIONS AND RESPONSIBILITIES

- 30. All photos must be the original work of the entrant and must not infringe the copyright or other intellectual property rights of any person or organisation;
- 31. The entrant will retain copyright in any photos submitted to the Competition.
- 32. By entering the Competition you grant to the Crown in right of Tasmania, a non- exclusive, royalty free, worldwide, perpetual licence to publish your photo(s) on the cover of any of TASMAP's paper maps, on the TASMAP website, its corporate website and social media websites (such as Facebook and Twitter), and otherwise use the photo, in connection with this Competition.
- 33. In the event that your photo is one of the Competition winners, you will be deemed to have further granted to the Crown a non-exclusive, royalty free, worldwide and perpetual licence to publish the photo(s) on the cover of any of the TASMAP paper maps, on the TASMAP website, in promotional materials and otherwise use the photo in connection with the business of TASMAP. If your photo is appearing on one of our map covers, we assume that you will want your name to appear on the map to indicate that you are the photographer/copyright owner and by entering the Competition you agree that we can do this.
- 34. For the avoidance of doubt, no fees will be payable by the Crown in right of Tasmania for any use of your photo(s) in connection with this Competition. In the event that we would like to use your photo for any other purpose and you are not a winner of this competition, we will contact you to discuss terms of use.
- 35. By entering the Competition you agree to take part in any reasonable promotions and publicity relating to it.
- 36. You warrant to the Crown in right of Tasmania that the image files you submit do not contain any viruses or other potentially harmful material.

GENERAL

- 37. By entering this Competition you will be providing the Department of Primary Industries, Parks, Water and the Environment with personal information as defined in the *Personal Information Protection Act 2004*. Any such information will be dealt with in accordance with that Act. In particular, by entering this Competition you will be deemed to have provided the Department with consent to the disclosure of any of that personal information, including (if necessary) your name and other relevant personal details on the back cover of a TASMAP product, for the purposes of acknowledging you as the person who took the photograph appearing on the front cover and the owner of the copyright in that photograph.
- 38. The Crown in right of Tasmania disclaim all liability for any loss or damage to persons or property, (whether direct or indirect) incurred by any person in connection with the taking and submission of photos in connection with this Competition, to the maximum extent permitted by law.
- 39. The Crown in right of Tasmania reserves the right to disqualify any entrants from the Competition and/or withdraw a prize from a winning entrant if in its opinion there is a potential breach of these Competition terms and conditions.
- 40. The Crown in right of Tasmania reserves the right to cancel this Competition or alter any of the terms and conditions at any stage, if in its opinion it is necessary to do so or circumstances arise outside of its control.
- 41. These Competition terms and conditions shall be governed by Australian Law and the Australian courts shall have exclusive jurisdiction.
